In support of strengthening student academic achievement, **George W. DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

Section A: JOINTLY DEVELOPED

George W. Sharswood School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Parents were invited on January 21, 2020, to provide feedback on the Schoolwide Plan, the school budget, and the 1% parent involvement funds available to support parents with their child's education. In the spring, parents will be invited to participate in the joint development of the Parent and Family Engagement Policy and School Compact. This year, the parent input meeting was held on April 29th, 2020.

Throughout the year, monthly School Advisory Council meetings will occur to enable an ongoing plan for parental involvement and specifically discuss the policies. Questionnaires were distributed to parents in order to collect feedback on what we can do here at Sharswood in order to better meet parents' needs. Parents will work closely with the teachers and principal in meeting the needs of students, parents, and staff.

Section B: ANNUAL TITLE I MEETING

George W. Sharswood School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

Parents will be invited to the annual Title I meeting held in the Fall. At this time, the principal or designee will share information about the requirements of Title I part A, parent rights to know, state and local assessments including the PSSAs, school curriculum, how to work with educators and to track student progress.

George W. Monthly Calendars, newsletters and general letters of information are sent home in a timely fashion as well as in an appropriate language that can be clearly understood by our families. In addition, we will send flyers and other correspondence in order to keep parents informed about upcoming programs and opportunities offered by the school, district and community. The principal will schedule monthly "Coffee with Administration" meetings to discuss parent concerns, communicate important information and answer questions that may arise. Whenever necessary, Bilingual Counseling Assistants are available to help communicate with parents who may have a language barrier. Robo calls are used to keep parents informed and up-to-date with upcoming activities.

Parents will be invited to review and update the School Parent compact during the Spring Title I meeting. This year, the meeting was held on April 29, 2020. We held the meeting virtually through Google Meet. The invitation had a link for parents/guardians to complete with their emails and a link to our meeting was emailed to them on April 29, 2020.

Monthly School Advisory Council Meetings are also an opportunity for parents to contribute ideas to develop an ongoing plan for parental involvement and specifically discuss the Compact and Family Engagement Policy. Questionnaires were distributed to parents in order to collect feedback on what we can do here at Sharswood in order to better meet parents' needs.

Parents will be invited to the annual Title I Winter Parent Input meeting to discuss the comprehensive plan and school needs, and also discussed potential purchases with the 1% set aside parent involvement funds. This year the meeting was held on January 21, 2020. School Advisory Council meetings will occur to enable an ongoing plan for parental involvement and potential purchases using the 1% set-aside.

Section F: COORDINATION OF SERVICES

George W. Sharswood School will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

All activities/workshops and special school events/activities include Pre-K through eighth grades. Through the Reading is Fundamental Program, parents are encouraged to become familiar with literature to read with their children at home. In addition, parents are exposed to reading strategies to help parents work at home with their child .

All parents are encouraged to attend School Advisory Council Meetings and workshops. Parents are encouraged to attend our Back to School Night in the Fall to meet their child's teachers and learn about the curriculum that will be presented.

In the Spring, we host an open house for our Kindergarten program as well as those in the neighborhood. This allows the opportunity to meet with the teachers and administrators. This

year the Kindergarten Parents will be invited to attend a workshop presented by a representative from the American Reading Company as part of a study we are involved in with University of Penn.

Section G: BUILDING CAPACITY OF PARENTS

George W. Sharswood School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of challenging State academic standards; and
2. Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
3. Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
 - a) The challenging State's academic standards
 - b) The State and local academic assessments including alternate assessments
 - c) The requirements of Title I, Part A
 - d) How to monitor their child's progress
 - e) How to work with educators to improve the achievement of their child

During the Annual Title I meeting in the fall, the principal will review the academic standards, assessments, Title I requirements, how to monitor your child's progress, how to work with educators, and an overview of the curriculum. In September, every child is sent home with a copy of the District's Code of Conduct. The Code of Conduct informs parents of the District's policies and procedures and the educational goals for students. On a monthly basis beginning in October, School Advisory Council Meetings are held. Our Principal, Dean of Students, Teacher Leader, Counselors, and Nurse are available to meet with our parents to give them strategies that they can use to assist their child. They also receive information on interpreting the data and how they can continue to support their child. The classroom teachers inform parents on a regular basis about their child's academic progress. Phone calls, letters home and individual conferences are held to express a concern or to praise a student's accomplishments.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

George W. Sharswood School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school.

The principal will share the parent survey results and address the topic "Working with Parents as Equal Partners" during a professional development day during the Fall/Winter. The school will also utilize the services of the Dean of Students, Bilingual Counselor and School Counselor in order to help bridge the gap between the school community and the families.

George W. Sharswood Elementary School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

Provide Literacy and Technology workshops to parents on supporting student achievement and parent engagement. Monthly Calendars and informative information will be sent home in order to keep parents informed about what is going on in school. Parents are encouraged to play an active role in their child's education by volunteering around the school or by participating in special events.
